The Government of Khyber Pakhtunkhwa has received a Loan from IDA through World Bank towards the cost of the Khyber Pakhtunkhwa Tourism Development Project - Project (P-163562) and intends to apply part of the proceeds toward payments under the contracts for Balance/Additional Civil Works for Preservation, Development and Improvement of Archaeological Sites in Khyber Pakhtunkhwa. Bidding is open to all bidders from eligible source countries as defined in the "Guidelines: Procurement of Goods, Works and Non-consulting Services under IBRD loans and IDA Credits and Grants by World Bank Borrowers" dated January 2011 (Revised July 2014).
2. PMU KITE CWD now invites sealed bids from eligible Bidders / Contractors having relevant specialized codes i.e CE10 (General Civil Works), EE02 (Security, safety & surveillance system) & EE11 (Solar Works) for carrying out Balance/Additional Civil Works and improvement of Archaeological Sites in Khyber Pakhtunkhwa as follows:

Bidding will be conducted through the Single Stage Single Envelope process through Request for Bids (RFB) method on the National Market Approach in accordance with Para 6.5 and 6.6 Section VI of World Bank's Procurement Regulations for Borrowers for Goods, Works, Non-Consulting and Consulting Services and applicable to Investment Project Financing (IPF) hereinafter referred to as "Regulations" dated July 1, 2016, revised November 2017, August 2018 and November 2020 in addition, please refer to paragraphs 3.14 and 3.15 setting forth the World Bank's policy on conflict of interest.
4. In each lot, the bidder has to construct/rehabilitate/improve the archaeological site. Bidders may bid for one or more lots, evaluation and award will be on the basis of lots.

7. Bids must be delivered to the address below on or before Thursday, January 05th, 2023 at 11.00 am. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on the same day at 02.00pm.
8. All bids must be accompanied by a "Bid Security" equivalent to 2% of the bid cost in the shape of a CDR (Call Deposit Receipt) in the favor of the Project Director, PMU-KITE CWD.
